“Photograph the emergency safely”

From 1 May to 4 September 2022

THE COMPETITION

The competition "Photo contest REAS – Fotografa l'emergenza in sicurezza", promoted by **CENTRO FIERA S.p.A.** as part of REAS exhibition, in collaboration with **Photogek Fenaroli** atelier, intends to raise awareness and dissemination of the theme of the emergency, selecting photographs capable of effectively describing the voluntary activity and the context in which groups and associations involved in emergency management operate.

PROPOSER SUBJECTS AND METHOD OF PARTICIPATION

- Participation in the competition is free and open to all volunteers in the emergency sector aged 18 and over.
- It is possible to participate individually or in associated form.
- In the case of participation in associated form, at least three quarters of the group members must fall within the expected age range (18 years and up); each group must indicate a representative who will be the contact person for communications by the organization.
- Unpublished photos taken with any technique, recording tool and narrative type are admitted to the competition.
- Photos must feature original, non-copyrighted content.
- For photos depicting identifiable faces (close-ups or recognizable people in general), the release is required. In the case of minors, the release must be signed by both parents.
- In the event that the images refer to facts, events, ceremonies of public interest, it is also possible not to request the release from the subjects shot only if the shots are general panoramas and do not dwell on one or more specific persons.

REQUIRED DOCUMENTATION

Registration for the "Photo contest REAS 2022" is free.

Send up to 3 photos and **A / B** forms in one of these options:

- Email to **photocontestreas@centrofiera.it** attaching a maximum of 7 MB.
- WeTransfer at **photocontestreas@centrofiera.it** if the files exceed 7 MB.
- HOW TO RENAME THE FILE: name surname-city-sequence number(eg: mario-rossi-brescia-1.jpg, mario-rossi-brescia-2.jpg, mario-rossi-brescia-3.jpg).
- Minimum resolution accepted FULL HD 1920x1080 in any photographic format (.jpg, .png, .psd, .pdf, .tiff).

FORMS TO FILL IN

A. Individual registration form, also including the release form for the use of the photo and the authorization to process personal data.

OR

B. Registration form in associated form, also including the release form for the use of the photo and the authorization to process personal data.

C. Individual release for the subjects filmed, to be filled in and signed by each of the persons appearing in the photos.

The participation forms are available on **www.reasonline.it/photocontest**.

All materials must be received in the manner described above **no later than 11.00 pm on 4 September 2022** under penalty of exclusion.

The day and time of receipt of the e-mail will be valid.

JURY AND PHASES

Centro Fiera S.p.A. will appoint a Technical Jury composed of professionals from the cultural / photographic sector who will have the task of evaluating the photographs received, selecting those capable of capturing the spirit and passion of those who work in emergency management in the most authentic way. Photographs in which defenseless bodies or in any case non-respectful of human dignity are portrayed will not be taken into consideration. The Jury will draw up a ranking and decide the works that will take part in the final phase. The author / author or authors of the finalist photographs will be contacted by e-mail or telephone and the names will be published on the website www.reasonline.it.

If the Technical Jury deems that none of the works presented are worthy of an award, they can limit themselves to reporting through their own means of communication.

In September 2022, the finalists will be announced through the website and the official social media channels of REAS upon the unquestionable decision of the Technical Jury. At this stage, voting will also be open to the Web-Social Jury, made up of all / and those who wish to express their preference. The Web-Social Jury will be asked to cast its vote according to the methods indicated in the appropriate section of the website www.reasonline.it, in the 20 days following the nomination of the finalists by the Technical Jury (end of September 2022) .

The weight on the final vote by the Web-Social Jury will be 20% (twenty percent). The decisions of the jury, unappealable, will be made public on the day of the award ceremony.

TO THE WINNING WORK

The award ceremony will take place on **Sunday 9 October 2022** as part of REAS (if allowed by the measures to prevent contagion from COVID-19).

The winning work will be included in the promotional materials of REAS and will accompany the dissemination activities that the project dedicates to the world of emergency volunteering, carried out in collaboration with organizations, institutions and companies in the sector.

The first 3 classified will be recognized as absolute winners of the first edition of the "Photo contest REAS – Fotografare l'emergenza in sicurezza".

The 30 best photographs will be included in the exhibition set up on the occasion of REAS on 7-8-9 October 2022 and in the gallery dedicated to the contest published on www.reasonline.it and in the institutional social channels of the project .
