INFORMATIVA SULLA PRIVACY

Dear interested party providing to CENTRO FIERA S.p.A. your personal data, we wish to inform you that the "European Regulation 2016/679 concerning the protection of individuals with regard to the processing of personal data, as well as the free circulation of such data" (from now on GDPR) provides for the protection of persons and of other subjects regarding the processing of personal data. as "Owner" of the treatment, pursuant to article 13 of the GDPR, therefore, provides you with the following information:

Purpose of the processing - CENTRO FIERA SPA will process your personal data for the creation of content in support of the activity linked to REAS 2023, to raise awareness of the issues: civil protection, first aid and fire prevention

Methods of data processing - The personal data you provide will be subject to processing operations in compliance with the aforementioned legislation and the confidentiality obligations which inspire the activity of CENTRO FIERA S.p.A.

These data will be processed both with IT tools and on any other type of suitable support, in compliance with the security measures provided for by the GDPR.

Whether or not consent is required - The provision of your data is optional. Failure to consent will not allow the use of the images and / or audiovisual footage of the interested party for the purposes indicated above.

Communication and dissemination of data - Within the limits relevant to the processing purposes indicated, personal data (PRINTED PHOTOGRAPHS AND FILES) may be communicated to all project partners within which the activity for which the data is requested is carried out in object.

These data will be disseminated, without commercial purposes, on the website www.reasonline.it, on the channels of the project partners, on the social channels of REAS and of the project partners (Facebook, Youtube, Instagram, LinkedIn), on printed paper and / or on any other means of dissemination.

Data Controller and Data Processors - The data controller is CENTRO FIERA S.p.A. .. The Data Processors are promptly identified in the Privacy Document, updated every year, and duly appointed.

Rights of the interested party - You can exercise your rights towards the data controller at any time, pursuant to Articles from 15 to 22 and art. 34 of the GDPR.

Retention period - The data collected will be kept for a period of time not exceeding the achievement of the purposes for which they are processed ("conservation limitation principle", Article 5, GDPR) and / or for the time necessary for obligations of law. The verification of the obsolescence of the data stored in relation to the purposes for which they were collected is carried out periodically.
